TRUST ACQUIRES ANOTHER PLOT

Trust has bought a 4.7 cents of land belonging to Cochin Thirumala Devaswom, leading to its present site at Dr Narmada & Dayanand Kamath Multipurpose Charitable Complex at Karnakodam. The narrow strip of land will enhance the access to the project.

TRUST ACTIVITIES

1. Dr Narmada and Dayanand Kamath Multipurpose Charitable Complex : Karnakodam



Sri S Prabhakara Prabhu, our Patron & President of Shree Sudheendra Medical Mission briefed on this project, after laying the foundation stone on 5th May 2005.

The project with about 28000 sqft is built on a 27 cents of land near T D Temple, Karnakodam. The complex

consists of a cellar and three floors. While two floors will have facilities to conduct socio-religious and cultural programmes, the third one will house mentally and physically challenged and orphans. The project is scheduled to be functional by October 2006.

2. Dr. Narmada Dayanand Kamath Senior Citizens' Home - Ernakulam

There are about fourteen inmates as on date from various quarters of life and different parts of the country who are making this Home lively. Trust has organized various activities for their benefit. Inmates were taken to participate in Aratu festival at Ayeekhal Sree Varaha Devaswom, Cherai and also to Ambalamedu to perform Seva to H H Sreemad Sudheendra Theertha Swamiji and received Swamijies blessings.

Satyanarayana Pooja is being conducted every month and everybody joins in devotional Bhajans.

3. Senior Citizens' Forum

Sri A Sudhakara Shenoy, Management Consultant, professional counselor and co-ordinator of JEEVITH SANTWAN (counseling center) conducted a workshop on "How to Live Happily" on 31st May 2006.

4. DR NARMADA AND DAYANAND KAMATH FREE HOUSING COMPLEX – PANDIKUDI



This unique project is to provide free shelter to those weaker section who cannot afford to own a house. When completed, families can have decent accommodation and lead an enhanced quality of life.



The Bhoomipoojan was blessed by H H Sreemad Sudheendra Theertha Swamiji on 23rd July 2005. (The gist of Swamiji's Ashirvachan on the occasion is given in page 1) The ceremony was attended by a large gathering.



Subsequently on 17th March 2006 foundation stone was laid by our Patron Sri S Prabhakara Prabhu. The function was graced by Corporation Councillors Mrs Shyamala Prabhu and Mr Hyacinth. The contract for the civil work has been awarded and the work is in full swing. The complex will come up on a plot of 27 cents adjacent to Cochin College, Padikudi and is expected to be completed by the end of year 2007.

5. VIDHYA SAHAYA NIDHI

Trust has continued its activities under this scheme which has benefited more than one thousand five hundred students by providing note books, umbrella, text books, uniforms, fees and cash awards.

The annual distribution of books for the year 2005 was done on 29th May 2005 at the residence of Late Sri A Krishna Bhat, Ernakulam. This was inaugurated by Sri S Prabhakara Prabhu, our Patron and President of Sree Sudheendra Medical Mission. He enumerated various activities of the Trust and also informed about the new project for Mentally & Physically challenged at Karnakodam. Around 700 students were benefited from this noble cause. Another 214 pupils were given financial assistance to buy text books.

OBITUARY

Professor R K Rao (4-7-1914 : 11-7-2005), freedom fighter, scholar and true Gandhian who strived for the promotional of Konkani language and culture now lives only in our memories. He has authored many books and also translated Thakazhi's famous novel *Rendidengazhi* into Konkani which fetched him the Kendra Sahitya Akademi Award for translation. He was a multifacial personality and had marveled by his contributions in academic, cultural, social and linguistic fields. He served as the head of the department of Hindi at St Alberts College, Ernakulam.



It was on the recommendation of the linguistic minority committee in which Prof Rao represented Konkani language, that former primeminister Smt Indira Gandhi agreed to include Konkani language in the eighth schedule of the constitution with Devanagiri as script. He was also a homeo doctor with class A registration. As a reformist he was one among the first in the community to marry a widow. Late Yamuna Bai was his wife.

Our Trust is very much indebted to Sri Raomam for facilitating us during the inauguration of Dr. Narmada Dayanand Kamath Senior Citizens' Home.

A unique charitable complex which will provide shelter to the Mentally & Physically challenged and orphans is nearing completion in a sprawling 27 cents of land in Karnakodam. Situated near T D Temple and Shivalaya and embedded by the housing colonies of our Samaj bandhavs, this project is expected to provide a meeting point for many social, religious and cultural activities.

Total of 28000 sqft of building will have dormitories, utilities and kitchen. The ground floor will have a 5500 sqft Pooja Mandir cum dining with modern kitchen facilities and abundant utilities. First floor will house a 7000 sqft facility to be used for social and religious functions. Second floor will be utilised to accomodate deserving people. Trust has already adopted two families and are being looked after for the last three years. The complex will have parking facility in the cellar floor and is scheduled for inauguration any date after October 2006.
